Call the combined Special and Regular Meetings of the Trustees of the Tulsa Airports Improvement Trust and the Members of the Tulsa Airport Authority to order.

- 1. Approve the minutes of the combined February 9, 2023 meetings of TAIT and TAA.
- 2. CEO and CFO Reports.

Administrative, Finance, IT, Operations, and Finance Contract Action.

3. Approve agreement between Public Service Company of Oklahoma ("PSO") and TAIT to perform an Airport Power Quality Assessment, in an amount not to exceed \$25,000.

This project will allow the Electric Power Research Institute, Inc., ("EPRI") to perform a 12-week Power Quality assessment to determine the cause of ongoing power quality issues at the airport. The total cost of this assessment is \$50,000 and PSO is splitting the cost of this assessment with the Airport.

- 4. Accept selection and approve professional services agreement with Garver for electrical consulting services for one year, with four one-year options to renew for an amount up to \$100,000 per year. The Airport received four statements of qualification. This contract provides electrical engineering consulting and on-call / troubleshooting professional services on an asneeded basis. Garver will bill hourly rates for work performed. TUL contract F23-070.
- 5. Approve agreement with AVI SPL, LLC for the provision of parts and professional installation services for the PA system upgrade project in the amount of \$254,770.21.

This project will utilize the State Contract ITSW1021. TUL contract F23-068.

6. Approve Professional Services Agreement for procurement and implementation of Microsoft Dynamics 365 Finance & Operation with Crowe, LLP in an amount not to exceed \$1,099,041.00 TUL contract F23-069.

The includes core implementation services in the amount of \$896,000.00, optional post-cutover support in the amount of \$32,000.00 and three years of software subscription licenses in the following amounts per year:
