Call Combined Annual Meetings of the Trustees of the Tulsa Airports Improvement Trust and the Members of the Tulsa Airport Authority to order.

- 1. Approve the minutes of the combined August 10, 2023 meetings of TAIT and TAA.
- 2. Election of Officers Chairman, Vice Chairman, and Secretary.
- 3. Submittal of Secretary's annual report pursuant to the TAIT Trust Indenture.
- 4. Operating and Financial Reports.

Administrative, Finance, IT, and Operations Contract Action.

5. Approve the September 14, 2023, Tulsa Airports Improvement Trust Purchasing Policy.

The last revision to the Purchasing Policy was October 10, 2021. Airport staff made comprehensive changes to the new proposed policy. A summary of the major changes include:

- Raising the maximum dollar limits for purchases made by employees (with a levelappropriate approval structure) from \$2,499.99 to \$4,999.99;
- Adding procedures for the use of P-Card for Purchase Orders and other methods;
- Adding regulatory requirements for purchasing which were not referenced in the previous policy;
- Amending the entire policy for improvement in clarity; and
- Changing the "lowest responsible bidder" award criteria to a "best value" award, and providing specific examples of what is required to award a contract under "best value" criteria.
- 6. Approve contract for asset valuation appraisal services with Aon Global Risk Consulting in the amount of \$27,000.00. TUL Contract F24-033.

Four bids were received ranging from \$17,000 to \$150,000, and were evaluated for best value by the selection committee. These services will give us an accurate picture of the replacement value of our property for insurance purposes.

7. Approve purchase from Axon Enterprise, Inc., for 33 Axon body worn cameras and one year of licensing and cloud storage services in an amount not to exceed \$40,104.50.

This contract will replace our existing body worn camera system for Tulsa Airport Police Officers and Tulsa Airport Landside Agents. The contract will include four additional years of licensing and cloud storage services at an annual cost of \$9,144.63. The body cameras will be purchased using Oklahoma State Contract OK-MA-145-015. TUL Contract F23-032.

8. Approve purchase from Bill Knight Ford for one new 2022 Ford F250 4x4 Super Cab in an amount not to exceed \$51,833.00. This will be purchased under Oklahoma state contract SW035.

The cost of this vehicle is under the budgeted amount of \$55,000.00.

- 9. Approve Memorandum of Agreement between the Federal Aviation Administration (FAA) and Tulsa Airports Improvement Trust (TAIT) in the amount of \$40,000,000 from the Consolidated Appropriations Act, 2023 for the Tulsa International Airport Air Traffic Control Tower Project.
- 10. Approve Amendment Number One to the Five-Year Capital Improvement Plan (CIP) for Fiscal Years 2024-2028.
