Call the Combined Special Meeting of the Trustees of the Tulsa Airports Improvement Trust and Regular Meeting of the Members of the Tulsa Airport Authority to order.

- 1. Approve the minutes of the combined September 14, 2023 Annual Meetings of TAIT and TAA.
- 2. Operating and Financial Reports.

Administrative, Finance, IT, and Operations Contract Action.

3. Approve Professional Services Agreement with Landrum & Brown, Inc., for Airport Consultant Services required under the Amended and Restated Bond Indenture and TAIT's Lease with the City of Tulsa. TUL Contract F24-047.

Landrum & Brown will perform the required Five-Year Review, Passenger Facility Charge Application assistance and other requested services at the standard hourly rates per their proposal.

4. Discussion regarding the issuance of a three-year Revolving Line of Credit (RLOC) in an amount up to \$15 million, to provide interim financing for construction of the Air Traffic Control Tower Complex and the Federal Inspection Services Facility.

TAIT's financial advisor and Finance Director are in the process of evaluating seven bids. After this evaluation, a recommendation may be considered at the December TAIT meeting along with necessary documents for board approval.

- 5. Approve purchase from ADB Safegate Americas LLC, a sole source provider, in the amount of \$58,883.52, for the purchase of (2) LED Precision Approach Path Indicator (PAPI) Lights to replace the existing Runway 19R/1L lights at RVS.
- 6. Accept proposal and award contract to Orion Security Solutions, LLC, in the amount of \$249,883.00 for the replacement of electronic circuit boards to improve our security access control system. TUL Contract F24-050.

- 7. Accept proposal and award contract to ControlTouch Systems, LLC, a sole source provider, in an amount not to exceed \$630,000.00 for the upgrade of the baggage handling system variable frequency drives. TUL Contract F24-049.
- 8. Approve TAIT 2023-2026 Disadvantaged Business Enterprise (DBE) Program in accordance with the regulations of the U.S. Department of Transportation. The revised DBE program contains updated DBE Objectives, Policy Statements, and DBE Triennial Goal setting guidelines for TUL and RVS.
- 9. Approve award of a Professional Services Agreement to Pavlov Advertising, LLC for marketing campaign creation and media buying services in the agreed upon hourly services rates. The Term of agreement is two years, with an option-to-extend for one year. TUL Contract F24-044.
- 10. Receive for initial consideration the draft Tulsa International Airport (TUL) Five-Year Airport Capital Improvement Plan (CIP) for Fiscal Years 2025-2029.

This initial draft of the TUL CIP identifies 26 projects totaling \$77,878,000.

11. Receive for initial consideration the draft Tulsa Riverside Airport (RVS) Five-Year Airport Capital Improvement Plan (CIP) for Fiscal Years 2025-2029.

This initial draft of the RVS CIP identifies five projects totaling \$7,133,000.

- 12. Approve Beneficiary Agreement between the Board of County Commissioners of Tulsa County and TAIT in the amount of \$7,000,000.00, to provide capital funding for the construction of the Air Traffic Control Tower (Project PJ1505 ARP58 CMF 20212403).
- 13. Accept and approve pending FAA BIL Grant Number 3-40-0099-110-2024 in an amount up to \$9,500,000.00 for the construction of the General Aviation & Federal Inspection Services Facility Project.
- 14. Accept and approve pending FAA Supplemental Discretionary Grant Number 3-40-0099-109-2024 in an amount up to \$5,000,000.00 for the construction of the General Aviation & Federal Inspection Services Facility Project.
- 15. Accept and approve pending Oklahoma Aeronautics Commission (OAC) Grant Number RVS-24-FS in an amount up to \$215,000.00 for the construction of the Riverside Taxiway Connectors Phase 2 Project.
- 16. Enter into a Reimbursable Agreement (RA) with the FAA in an amount not to exceed \$17,700,000, to be used for the design and installation of FAA equipment in the Air Traffic Control Tower (ATCT) and base building, contingent on receipt of a signed Memorandum of Agreement (MOA) from the FAA.

Engineering Capital Improvement Contract Action.

Contracts.

17. Accept bids and approve award of contract for the Airport Terminal Vestibules Improvement Project to Myers-Cherry Construction, LLC, in the amount of \$2,447,000.00 contingent upon FAA BIL grant funding. TUL contract F24-045.

This contract provides funding to remove existing revolving doors and replace them with vestibules in both the ticketing and bag claim areas. TAIT received two bids, one of which was non-responsive. The engineer's estimate was \$2,075,000.00, 17.9% below the lowest responsible bidder. The DBE goal was 8.0%, and after a good faith effort the contractor proposes utilizing 8.0%.

18. Accept bids and approve award of contract for the Tulsa International Airport Entrance Signage Project to Lowry Construction Services Inc., in the amount of \$749,149.00. TUL contract F24-051.

This contract provides funding to remove the existing entrance sign and construct a new entrance monument. TAIT received four bids ranging from \$749,149.00 to \$1,242,480.00. The engineer's estimate was \$1,053,738.00, 29.9% above the lowest responsible bidder.

19. Accept bids and approve award of contract for the General Aviation & Federal Inspection Services Facility (GA/FIS) Project, to Flintco, LLC, in the amount of \$34,888,000.00, contingent on FAA Grant Funding. TUL contract F24-043.

This contract provides funding to construct the new GA/FIS facility. TAIT received two bids, \$34,888,000 and \$35,684,000. The architect's estimate was \$31,600,000, 9.4% below the lowest responsible bidder. The DBE goal was 9%, and after a good faith effort the contractor proposes utilizing 1.9%.
