Call the Combined Special Meeting of the Trustees of the Tulsa Airports Improvement Trust and Regular Meeting of the Members of the Tulsa Airport Authority to order.

- 1. Approve the minutes of the combined November 9, 2023 meetings of TAIT and TAA.
- 2. Operating and Financial Reports.

Administrative, Finance, IT, and Operations Contract Action.

- 3. Receive and file the Tulsa Airports Improvement Trust Audited Financial Reports for the fiscal year ended June 30, 2023, along with other related reports prepared by RSM US, LLP.
- 4. Approve revisions to the TAIT Employee Handbook, formally called, the Human Resources Policy Manual. The proposed revisions were provided in advance to the Trustees prior to consideration.
- 5. Approve Agreement with Blue Cross Blue Shield of Oklahoma (BCBSOK) for annual medical insurance coverage in an amount not to exceed \$1,600,000.00, effective January 1, 2024.

The estimated amount of the agreement is \$1,480,197.76 and represents a 1.1% increase from the previous plan year. The contract amount depends on enrollment numbers. All plans are the same as the previous year.

6. Approve Agreement with BCBSOK for dental insurance in an amount not to exceed \$110,000.00, effective January 1, 2024.

The estimated amount of the Agreement is \$103,668.24 and represents a 5.01% increase from the previous plan year. The contract amount depends on enrollment numbers. All plans are the same as the previous year.

7. Amend award of contract to ControlTouch Systems, LLC, a sole source provider, in an amount not to exceed \$653,000.00 for the upgrade of the baggage handling system variable frequency drives. TUL contract F24-049.

8. Approve Distributed Energy Resource Agreement between TAIT and Voltus, Inc., for a term of 5 years. TUL contract F24-058.

Voltus will provide curtailment dispatch opportunities at peak times of electrical usage over the Southwest Power Pool Grid. When TAIT chooses to participate in the curtailment, TAIT will get reimbursed 51% of the calculated value of energy savings. TAIT has the right to terminate the contract at any time.

9. Reject bids and withdraw Request for Proposal #IT-Wayfinding23. This RFP was issued to refresh and update all the electronic displays inside the terminal building. TAIT received one bid, which was over the budgeted amount.

Agenda Items 10 and 11 may be considered together.

- 10. Reject bids for Request for Proposal #IT-ACC23, and rescind award of Agreement to Orion Security Solutions, LLC, in the amount of \$249,883.00 for the replacement of electronic circuit boards to improve TAIT's security access control system. The sole bid received was non-responsive.
- 11. Approve Agreement with Orion Security Solutions, LLC for project IT-ACC23-2 in the amount of \$249,883.00 for the replacement of electronic circuit boards to improve TAIT's security access control system. TAIT will utilize Oklahoma State Contract SW1048O. TUL contract F24-050.
- 12. Approve Five-Year airport Capital Improvement Plans (CIP) for Fiscal Years 2025-2029 for Tulsa International Airport and Tulsa Riverside Airport.

The proposed CIP for TUL identifies twenty six (26) projects totaling \$80,326,000.00.

Anticipated Fiscal Year 2025 projects for TUL are: Taxiway K reconstruction, Taxiway M rehabilitation, Pavement Management System upgrade, restroom improvements in the lower-level terminal and bag claim area, security fencing improvements, landside cargo pavement rehabilitation, replacement of the ARFF roof and the continuation of the wayfinding sign upgrade.

The proposed CIP for RVS identifies five (5) projects totaling \$7,645,000.00.

Anticipated Fiscal Year 2025 projects for RVS are: The designs for a drainage project near the entrance of the airport, realignment of Taxiway GG and the associated perimeter road, and the rehabilitation and widening of Runway 13/31.

13. Accept and approve pending FAA BIL Grant Number 3-40-0099-112-2023 in an amount up to \$2,610,000.00 for the construction of the Airport Terminal Vestibules Improvement Project. TUL Grant.

14. Amend pending FAA BIL Grant Number 3-40-0099-110-2023 by adding \$1,900,000.00 to the grant award for the total amount up to \$11,400,000.00 for the construction of the General Aviation & Federal Inspection Services Facility Project. The previous award was an amount up to \$9,500,000.00. TUL Grant.

15. Accept bids and approve award of contract for the Employee Parking Lot "A" Expansion Project to Ellsworth Construction, LLC, in the amount of \$565,161.90. TUL contract F24-059.

This contract provides funding to expand the employee lot "A" from 230 to 407 parking spaces. TAIT received eight bids, ranging from \$565,161.90 to \$1,012,437.20. The engineer's estimate was \$808,158.00, 43% above the lowest responsible bidder.

16. Accept selection and approve award of contract for Professional Design Services to H. W. Lochner, Inc., in the amount of \$99,642.24 for the Wayfinding Implementation Project. TUL contract F24-063.

17. Approve Change Order Number Three with Third Generation Electrical, Inc., to extend contract time by 65 calendar days due to supply chain issues. There will be no additional compensation made due to this time extension. Parking Garage Level 1 EV Charging Stations Project. TUL Contract F23-051.

The contractor has identified a delay in delivery of automatic transfer switches and main distribution panels due to supply chain issues. The original contract time was 365 calendar days, the new contract time will be 425 calendar days.
