This agreement is to replace the aging/failing wireless communications that support TAIT's badging and camera systems at certain Perimeter Entry Gates. TAIT received three bids ranging from \$223,837.00 to \$445,305.00.

This contract provides funding to prepare plans and specifications to replace the roof in areas E, F and G of the terminal building.

7. Accept selection and approve award of Professional Services Agreement to TranSystems Corporation in an amount not to exceed \$393,500.00 for the Consolidated Rent-A-Car (CONRAC) facility development study. TUL contract F25-072.

This contract provides funding to develop up to five options for the new CONRAC facility and develop a long-range plan for public parking and airport employee parking. Three submittals were provided in response to the RFQ.
