1. Call the combined special meeting of the Trustees of the Tulsa Airports Improvement Trust ("TAIT") and regular meeting of the Members of the Tulsa Airport Authority ("TAA") to order.
2. Approve the minutes of the June 12, 2025, combined meetings of TAIT and TAA.

4. Approve purchase of a John Deere 6M 140 Tractor from P&K Equipment, Inc., in an amount not to exceed \$233,530.22. RVS. State Contract SW0196JD.
5. Accept and approve pending FAA Airport Improvement Program ("AIP") Grant in an amount up to \$250,000.00, for the Preliminary Design Report of the Runway 8-26 Rehabilitation Project. AIP Grant 3-40-0099-117-2025 TUL.

6. Accept and approve pending FAA Voluntary Airport Low Emissions Program (VALE) Grant in an amount up to \$1,450,000.00, for the Airport Vehicle Electrification Project. VALE Grant 3-40-0099-120-2025 TUL.

**Engineering Capital Improvement Contract Action.**

**Contracts.**

7. Accept bid and approve award of contract to Third Generation Electric Inc. ("TGE"), in the amount of \$595,460.00, for the Airport Vehicle Electrification Project, contingent upon FAA VALE Grant funding. TUL contract F26-006.

This contract provides funding to install the infrastructure to supply electrical power to eight vehicle charging stations. TAIT received one bid. The engineer's estimate was \$416,426.00,

43% below the TGE bid. The Disadvantaged Business Enterprise (“DBE”) goal was 1.9% and the contractor has committed to utilizing 1.9%.

8. Approve award of Professional Services Agreement with Garver, LLC., in an amount not to exceed \$121,980.00 for one year with four one-year TAIT options to extend, for the Arc Flash Maintenance Project. TUL F26-005.

This contract provides funding to update and maintain the Arc Flash Study and to incorporate all the projects that have taken place between April 2023 and December 2024.

9. Approve Amendment Number One to Agreement for Professional Services to Frankfurt-Short-Bruza-Associates, P.C., in an amount not to exceed \$18,558.00, for the Lower-Level Public Restroom Improvements Project. TUL contract F25-050.

This amendment adds the design to update the public restrooms outside the boardroom.

10. Approve Amendment Number One to Professional Services Agreement to KSA Engineers, Inc., extending the contract time by 215 calendar days for the Security Improvement Project. RVS contract F25-086.
