This contract provides funding to install approximately 12,000 of LF two-way 4" conduit and fiberoptic cabling. TAIT received two bids, the second bid was \$2,108,540.00, the engineer's estimate was \$2,475,000.00, 110% above the lowest responsible bidder.

- 11. Approve award of Professional Construction Administration Services Agreement with Garver, LLC, in an amount not to exceed \$170,631.00 for the FAA ILS Cable Replacement Project. TUL Contract F26-032.
- 12. Approve award of Professional Design Services Agreement with TranSystems Corporation in an amount not to exceed \$980,000.00 for the Rental Car and Public Parking Expansion Project. TUL contract F26-034.

This contract provides funding to perform Preliminary design services for plans from 0 to 30%.
