Engineering Capital Improvement Contract Action. Contracts.

10. Accept bids and approve award of contract to Barnes Construction Solutions, Inc., in the amount of \$3,813,323.50 for the Landside Cargo Pavement Rehabilitation Project. TUL contract F26-042.

This contract provides funding to remove and replace approximately 19,000 square yards of Portland Cement Concrete between Cargo Buildings 1, 2 and 3. TAIT received three bids, the highest was \$7,260,100.00. The engineer's estimate was \$5,295,549.00, which is 39% above the lowest responsible bidder.

- 11. Approve award of Professional Construction Administration Services Agreement with Olsson, Inc., in an amount not to exceed \$416,179.80 for the Landside Cargo Pavement Rehabilitation Project. TUL contract F26-048.
- 12. Accept bids and approve award of contract, pending FAA grant approval, to 357 Inc., dba RECO Construction in the amount of \$1,697,000.00 for the Lower-Level Restroom Improvements Project. TUL contract F26-043.

This contract provides funding to renovate the public restrooms in the lower-level bag claim, ticketing, and the TAIT conference rooms. TAIT received four bids, the highest was \$2,447,000.00. The engineer's estimate was \$2,479,222.00, which is 46% above the lowest responsible bidder.

- 13. Approve award of Professional Construction Administration Services Agreement with Frankfurt Short Bruza Associates, P.C., in an amount not to exceed \$73,336.00 for the Lower-Level Restroom Improvements Project. TUL contract F26-049.
- 14. Approve award of Professional Design Services Agreement with PDG, LLC, dba Planning Design Group in an amount not to exceed \$75,220.00 for the Plane Spotting Area Project. TUL contract F26-045.

This contract provides funding to perform design services for the plane spotting area south of the cargo apron.

15. Approve award of Professional Engineering Services Agreement with RDM International, Inc., in an amount not to exceed \$152,859.00 for the Pavement Management Update Project. TUL contract F26-046.

This contract provides funding to update the Airfield Pavement Management Plan. This work will identify an updated Pavement Condition Index ("PCI"), needed to allocate federal funding for future pavement improvements.
