3	DR.B1 sign-Please explain how do you want us to install new sign since the existing sign face is embedded to the horizontal wall structure. And please confirm that new sign will not be embedded like existing sign.	The intent is to flush mount these 2 signs on the existing surface - These signs are not intended to be embedded.
4	ID.B3 sign-please show exact sign location and mounting information on Far-out ceiling is 115" from the floor. And provide information on how far the sign needs to come down. Or if it is a side mount, how far the sign needs to stick out.	The intent is to suspend mount these 37 signs from the Far Out ceiling which measures 115" above the floor so the bottom of the sign is same elevation as the bottom of the lower furred out celing. These signs are not intended to be side mounted.
5	For sign type DR.A1, are there monitors on both sides of the sign?	Sign DR.A1 monitors are only on 1 side of the signs. Please also include cost for the supply of 4 monitors total (2 each sign) for Sign Line Item DR.A1 plus material supplies and labor to mpunt the monitors in DR.A1. Sign DR.B1 monitors are only on 1 side of the signs. Please also include cost for the supply of 2 monitors total (1 each sign) for Sign Line Item DR.B1 plus material supplies and labor to mount the monitors in DR.B1.
