1. Approve Amendment Number One to Small Community Air Service Development Program ("SCASD") Grant between TAIT and the U.S. Department of Transportation, in order to extend the term of the Grant Term, effective January 6, 2023. Grant DOT-OST-2017-0155-0050.

2. Approve purchase from Bill Knight Ford for one Ford Transit 250 rear wheel drive medium roof cargo van for TUL in an amount not to exceed \$53,954.00. This vehicle is over the fiscal year 2023 capital purchase budget amount of \$50,000 by \$3,954.00. This vehicle will replace 10-152.

This unit will be purchased under Oklahoma state contract SW035.

3. Approve Concession Services Agreement for one year, with Skylixor, LLC, to provide taxicab driver access to a web application allowing taxicab drivers to enter a virtual queue system. TAIT will pay Skylixor 3% of fees net of credit card charges. TUL contract F23-056.

4. Consider Amendment to the TAIT Ground Transportation Policy to accommodate new virtual queuing system.

This new taxi cab queuing system is still in the testing phases, and while testing we may need to change how the policy is stated. We expect to have a policy approved at the February

trustee's meeting.

5. Approve waiver of Section IV of TAIT's Rules & Order of Business to allow the approval of Agenda item number six below without the requirement of a second meeting to approve a policy change. The waiver is allowed under the current Rules.

6. Consider and approve Tulsa Airports Improvement Trust - Trustee's Meeting Rules and Order of Business, effective immediately upon approval.

7. Approve the following updates to the TAIT HR Policy Manual. All changes, with the exception of the new PTO Policy, are minimal.

8. Approve contract with Blue Cross Blue Shield of Oklahoma ("BCBSOK") for annual medical insurance coverage in an amount not to exceed \$1,500,000.00. Effective January 1, 2023.

The estimated amount of the contract is \$1,382,913.64 and represents a 10.1% savings from the previous plan year, and depends on enrollment numbers. We maintained the same high-deductible health plan (HDHP), 5000 PPO plan, and exchanged the low deductible plan with a similar low deductible plan which offers a lower co-pay for primary care offer visits.

9. Approve contract with BCBSOK for dental insurance in an amount not to exceed \$95,000.00. Effective January 1, 2023.

The estimated amount of the contract is \$87,781.32 and represents a 0.11% savings from the previous plan year. Last year MetLife provided similar coverage.

Four consultants submitted qualifications in response to the Airports RFQ. Garver was selected as the best qualified.
